These Terms and Conditions ("Terms") constitute a legally binding agreement between you ("User," "Trader," "You") and RISEFX CAPITAL LIMITED ("Company," "We," "Us," "Our"). By using our services, registering an account, or accessing our website or trading platform, you agree to these Terms in full.

1. Eligibility

- 1.1 You must be at least 18 years old or of legal age in your jurisdiction.
- 1.2 You must not be a citizen of or resident in any jurisdiction where access to our services is restricted or illegal.
- 1.3 You warrant that you are not violating any laws or regulations applicable to you by using ourservices.

2. Account Registration & Management

- 2.1 You agree to provide truthful, accurate, and complete registration information.
- 2.2 You are solely responsible for maintaining the confidentiality of your login credentials.
- 2.3 You must notify us immediately if you suspect any unauthorized use of your account.
- 2.4 We reserve the right to approve or reject any registration without explanation.
- 2.5 Each user is allowed only one account unless written permission is granted.

3. Account Funding and Withdrawals

- 3.1 Funds must be deposited via approved payment channels listed on the platform.
- 3.2 Withdrawals will only be processed to the verified account holder using the original paymentmethod.
- 3.3 All transactions are subject to AML/KYC compliance and may be delayed pending verification.
- 3.4 Fees, charges, or commissions will be clearly displayed and may vary based on services used.

4. Trading Services

- 4.1 Our platform offers trading in various financial instruments: forex, crypto, commodities, indices, stocks, and CFDs.
- 4.2 Market prices are sourced from trusted liquidity providers; however, we do not guarantee realtime accuracy or uptime.
- 4.3 Trading services may be interrupted for maintenance, and we are not liable for downtime ororder execution issues arising from such interruptions.
- 4.4 Leverage, margin requirements, and trading conditions are subject to change without priornotice.

5. Prohibited Trading Practices

5.1 You agree NOT to engage in any of the following:







- Market manipulation (e.g., spoofing, layering)
- Front-running
- Insider trading
- Quote stuffing
- Use of unauthorized trading software or bots Latency arbitrage
- 5.2 We reserve the right to void, cancel, or reverse trades that violate these rules or seem suspicious.

6. No Scalping Policy

6.1 Definition of Scalping

Scalping is defined as placing and closing a position within a short time period (typically seconds to minutes) to exploit minor price movements.

6.2 Prohibited Scalping Behaviour

- Opening and closing trades within 2 minutes
- Exceeding 25% of all trades without prior approval
- Using automated trading systems designed for microsecond trades
- Executing trades based on latency arbitrage
- Exploiting system bugs, slippage, or price lag
- Operating multiple accounts to bypass scalping restrictions
 6.3 Monitoring and Detection
- We monitor trade timestamps, trade volume, and IP addresses.
- We may use automated tools and algorithms to detect scalping behaviour.
 6.4 Consequences of Violations
- Warning and review of activity
- Trade cancellation or reversal
- Forfeiture of profits derived from prohibited trades
- Suspension or permanent termination of account and your capital will be withheld.
- Legal action for fraudulent or abusive behaviour

7. Leverage and Margin Policy

- 7.1 Users are required to maintain a minimum margin level as specified on the platform.
- 7.2 Positions may be closed automatically if margin drops below required thresholds.
- 7.3 Margin levels, leverage, and liquidation rules may change based on market volatility.

8. AML & KYC Compliance

- 8.1 You agree to comply with all applicable anti-money laundering and anti-terrorism financing laws.
- 8.2 We may request documentation to verify identity, address, source of funds, and trading purpose.
- 8.3 Failure to provide requested documents may result in account suspension or rejection of transactions.

- 9.1 We collect and process personal data according to our Privacy Policy.
- 9.2 We implement industry-standard security to protect user data, but we cannot guarantee absolute security.
- 9.3 We do not sell or lease user data to third parties without consent, except where required by law.

10. Intellectual Property

10.1 All content, trademarks, and platform code are the exclusive property of RISEFX.

10.2 Users are granted a limited, non-transferable, non-exclusive license to use the platform for trading purposes only.

11. Risk Disclosure

11.1 Trading financial instruments involves significant risk of loss and is not suitable for all investors.

11.2 Past performance is not indicative of future results.

11.3 You may lose more than your initial deposit.

11.4 You should only trade with funds you can afford to lose.

12. Limitation of

Liability12.1 We are not liable for:

- Losses arising from internet failure, system outages, or market disruption
- Errors in price feeds or platform delays
- Unauthorized access to your account due to your negligence
- 12.2 Our total liability shall not exceed the amount you have paid us in the last 6 months.

13. Force Majeure

We are not liable for delays or failure in performance resulting from events beyond our reasonable control, including but not limited to war, natural disasters, cyberattacks, or government intervention.

14. Account Termination

We reserve the right to terminate any user account without notice if:

- Terms are violated
- Activity is deemed fraudulent or abusive
- Compliance issues arise

Users may request account closure at any time, subject to clearing all balances.

15. Dispute Resolution

- 15.1 Any disputes shall first be attempted to be resolved amicably.
- 15.2 If unresolved, the dispute shall be referred to binding arbitration in UAE.
- 15.3 The governing law shall be the laws of UAE.
